Starting Saturday, March 21st, all P1FCU lobbies will have limited access until further notice and will be accessible to members by appointment only Monday through Friday. Our branches with drive-ups will be open with our normal operational hours.

Member Relief Resources

During this time of uncertainty caused by the outbreak of COVID-19, we understand the financial hardships many of our members are facing. P1FCU staff and management is working quickly to provide solutions to our members to instill peace of mind and relief to those who need it most. Please review the resources we have available to our members.

Member Financial Assistance Plan

Effective 3/1/20, P1FCU is offering a couple different relief options to assist our members during this difficult time.

- **P1FCU Member Assistance Signature Loan** – Get a low rate on a six to twelve month signature loan with no payments for 90 days, and borrow up to \$5,000*.
- **Skip Payment Assistance**** – You may skip your consumer loan payments for up to 2 months with no fee.
- **P1FCU Income Assistance Loan** – Borrow up to one month of your regular net pay at 0%*** for up to 3 months.
- **Fee Waivers: Effective 3/17/20**
 - Our Skip-A-Pay fee is being waived at least through April 24, 2020.
 - All loan late fees will be waived at least through April 24, 2020.
 - Our Pay by Phone convenience fee is being waived at least through April 24, 2020.

Your Money is SAFE

The safest place for your money is in a Credit Union. P1FCU accounts are federally insured by the NCUA up to \$250,000. To learn more, visit the NCUA website to run your personalized report. If you lose a debit or credit card, that loss may be covered. If you lose cash or it is stolen, it can't be replaced. P1FCU's accounts are the most secure place to keep your money. No one has ever lost a penny in savings on deposit at P1FCU or any other federally insured credit union.

Access to Your Money

It's good to have your standard spending cash on hand for day to day use, but with so many ways to access your money in your accounts, there isn't a need for extra cash. You will be able to continue to pay your bills and make transactions without interruption during the COVID-19 outbreak. Plus, you won't be running around with those extra bills in your wallet tempting you to spend it.

Social Distancing and Your Cash

While using safe social practices like social distancing and limited gatherings, you will probably need less cash on hand anyway. Why not keep that in your account and keep earning dividends?
