2023 has been a year of financial challenges for the United States economy. Efforts by the Federal Reserve Board to reduce inflation caused many adjustments to interest rates on loan and savings products in the marketplace as the Federal Funds Rate has increased 5 percentage points over the last 16 months. We have worked closely with members this year to assist them in securing loan products and securing deposit products to meet their financial needs and the challenges of these economic changes. There will remain to be a close watch on all the economic conditions affecting our membership and the United States as a whole during 2024.

Voting Online

You may vote for the candidates of your choice by going to our website, <https://www.p1fcu.org> and clicking the "Vote Now" button. You will be asked to provide your member number and the last four digits of your social security number. The candidates will be listed, and you simply click on the ones you wish to vote for. You will be able to vote online from Monday, January 8th, 2024, through Thursday,

January 25th, 2024, when ballots are called for during the Annual Business Meeting.

Voting In-Branch

Members 18 years and older may vote for the candidates of their choice by going into one of our branches and placing your vote in the ballot box. Voting will be allowed in-branch from Monday, January 8th, 2024, through Saturday, January 20th, 2024.

Voting by Paper

If you are more comfortable voting via paper ballot, call the toll-free number, 855-541-1452. You will be asked to provide your member number and the last four digits of your social security number. The ballot will be mailed to you and then returned via an enclosed postage paid envelope. Your ballot must be received by January 25th, 2024.
