



P1FCU 2026 Vandal Football Season Sweepstakes Rules:

- 1. - 3. How to Enter:** Electronic form submissions completed by an eligible individual at count as one entry. Completed submissions are submissions that include an entrant's name and sufficient contact information. Entrants may submit one eligible form per day during the sweepstakes period, all other submissions will be discarded. In total, entrants may accumulate 1 entry in the sweepstakes.
- 4. Odds:** Odds of winning a prize depend on the number of eligible entries received for each drawing. Non-winning entries will be carried over into the next drawing period.
