



2026 Youth Month Coloring Contest Rules

1. Entries will be judged by P1FCU staff based on creativity, coloring skill and overall artistic ability according to that age category. One winner from each age group per branch (6 and under, 7 years old to 10 years old, and 11 years old to 17 years old) This is a skill-based contest, and chance plays no part in the determination of winning.
2. NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not increase your odds of winning.
3. Contest begins April 1, 2026 at 12:01AM PST and ends April 30, 2026 at 11:59 PM PDT.
4. To enter, print out the image and color it using any medium you'd like. Email entry to marketing@p1fcu.org with the subject line "Youth Month Coloring Contest." Alternatively, entries can be brought into your local branch or mailed to P1FCU Marketing PO Box 897 Lewiston, ID 83501. Entry must include the child and parent or legal guardian's full name, child's age, and telephone number or email address. Any entries missing the above requirements will be immediately disqualified.
5. Entry must be received by P1FCU no later than 11:59 PM PDT on April 30, 2026, by email or mail. No other method of entry will be accepted.
6. Contact information collected will be used for the purposes of this contest only and will not be used for marketing or other purposes.
7. Limit one (1) entry per person.
8. Entrants must reside within P1FCU's field of membership, which includes the following Idaho counties: Ada, Adams, Benewah, Boise, Bonner, Boundary, Canyon, Clearwater, Gem, Idaho, Kootenai, Latah, Lewis, Nez Perce, Payette, Shoshone, Washington, and Valley, the following Oregon counties: Baker, Grant, Harney, Malheur, Morrow, Umatilla, Union and Wallowa, and the state of Washington.
9. All entries must be original and entirely created by the entrant. There are no restrictions on what an entrant can use to color the image.
10. Entries will be judged by P1FCU staff based on creativity, coloring skill, and overall artistic ability according to that age category. One winner from each age group (6 and under, 7-10, 11-17) will be determined by the judges at their sole discretion. The decisions of the judges will be final and binding in all respects.
11. Five (5) winners in the 6 and under age group; five (5) winners in the 7-10 age group; and five (5) winners in the 11-17 age group will be selected on or about May 8th, 2026. We will contact the potential winners by email on or about May 12th, 2026. The name, city, and state of the winners will be posted on the P1FCU website (www.p1fcu.org) and social media on or about May 15, 2026.
12. Winners will receive prizes by mail or picking them up in branch.
