



## P1FCU 2025 WALLA WALLA COUNTY FAIR AND FRONTIER DAYS SWEEPSTAKES:

- 1. Eligibility:** The P1FCU 2025 WALLA WALLA COUNTY FAIR AND FRONTIER DAYS SWEEPSTAKES is open to legal residents of the 50 United States and the District of Columbia, and who are 18 years of age and older at the time of the form entry (see How To Enter). Sweepstakes is subject to all applicable federal, state, local laws, and regulations. Void where prohibited by law.
