At P1FCU, we're committed to serving our members with speed, accuracy, convenience and innovation. That's why we've decided to upgrade to a system that will no longer hold us back from serving you in the best way possible. We have partnered with a leading provider in the financial services industry to upgrade our technology solutions.

Because of the complexity involved with upgrading our systems, there will be times during Labor Day Weekend that branches and online/mobile banking will be unavailable. Please review additional details on this page to prepare for these exciting changes.

August 31st - September 2nd

At P1FCU, we truly value every one of our members. We sincerely appreciate your understanding and patience as we navigate through these changes. We are committed to keeping you informed in the coming months, so please review all P1FCU correspondence. We are excited about these changes and look forward to serving you better in the future!

When will the upgrade happen?

The upgrade will take place over Labor Day Weekend. Our systems will be unavailable beginning Friday, August 30, 2019 at 6:00pm until Tuesday, September 3, 2019. Tuesday morning, all branches, call center and online/mobile banking will return to normal operations.

How does this system upgrade benefit me?

Our members will have a more convenient and streamlined banking experience, which will include enhancements to our product offerings.

Will my account number(member number) change?

No. Your account(member) number will not change due to the system upgrade.

Is my personal and financial information safe during the upgrade?

Yes. The safekeeping of member account and personal information is P1FCU's top priority. Personal data and account information will be safe and secure throughout the entire system upgrade.

Are my funds safe and secure?

Yes. Your funds continue to be insured by the NCUA. This will not change.

What else can I do to prepare?

One of the best ways to prepare for the upgrade is to verify that all your personal contact information with P1FCU is correct. You can do this by contacting us, or logging into online/mobile banking. If you don't currently have an email on file, be sure to add one. The more ways we can communicate with you in the coming months, the easier it will be to keep you informed.
